



ACCESS TO INFORMATION - PUBLICATION SCHEME FREEDOM OF INFORMATION ACT 2000 (Statutory)

The Governing Body is responsible for maintenance of this scheme.

1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all VA and maintained schools, should be clear and proactive about the information they will make public.

To do this we have produced this publication scheme, which sets out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available for you on our website to download and print off or available in paper form.

Some information which we hold may not be made public, for example personal information. This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives (our Mission Statement)

3. Categories of information published

Special Education Needs Policy	Information about the school's policy on providing for students with special educational needs
Accessibility Plans	Plan for increasing participation of disabled students in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled students.
Race Equality Policy	Statement of policy for promoting race equality
Collective Worship	Statement of arrangements for the required daily act of collective worship
Careers Education Policy	Statement of the programme of careers education provided for Key Stage 4
Child Protection Policy	Statement of policy for safeguarding and promoting welfare of students at the school.
Student Discipline	Statement of general principles on behaviour and discipline and of measures taken by the Headteacher to prevent bullying.
